## **Withdrawing Nominations**

Nominations cannot be withdrawn after 12:00pm Australian Eastern Daylight Time (AEDT) on 15/11/2021.

#### **Candidate Statements**

Candidates may submit a statement to be included with ballot material. A biography and/or a statement in support of their candidature and/or a photograph (a "candidate statement"), for publication on the organisation's website for distribution by the returning officer together with the ballot papers. The biography and/or statement shall not exceed 200 words. Only statements which comply with the Rules and are received by the Returning Officer by 12:00pm (Australian Eastern Daylight Time (AEDT)) on 15/11/2021 can be accepted.

## **Voting Period**

The ballot, if required, will open on 06/12/2021 and close at 5:00pm Australian Eastern Daylight Time (AEDT) on 10/01/2022.

#### **Scrutineers**

The appointment of scrutineers opens 12:00pm Australian Eastern Daylight Time (AEDT) on 01/11/2021 and closes 9:00am Australian Eastern Daylight Time (AEDT) on 11/01/2022.

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
